





ASSIGNMENT OF CLAIM AGREEMENT

Wellmar Corporation Ltd., an Alberta corporation, with registered office at #1404, 10301 – 104 Street NW, Edmonton, Alberta, T5J 1B9, Canada (“*Assignor*”), for good and valuable consideration which has been received, does hereby irrevocably sell, convey, transfer and assign to George Hardy and his successors and assigns, of 35 Eagle Drive, Sherwood Park, Alberta T8A 0E1, Canada (“*Assignee*”), all of Assignor’s right, title and interest in and to its 4d Customer Claim under PFG Master Account No. 33A09 (the “*Claim*”) evidenced by proof of claim numbers 6911, 7122, 6740 (the “*Proof of Claim*”) against Peregrine Financial Group, Inc. (the “*Debtor*”) in the chapter 7 liquidation case, being case no. 12-27488 (the “*Case*”), in the United States Bankruptcy Court for the Northern District of Illinois, Eastern Division (the “*Bankruptcy Court*”), and all rights and benefits of the Assignor relating to the Claim, including without limitation: (i) the Assignor’s right to receive interest, penalties and fees, if any, which may be paid with respect to the Claim, (ii) any actions, claims, rights or lawsuits of any nature whatsoever, whether against Debtor or any other party, arising out of or in connection with the Claim, and (iii) all cash, securities, instruments and other property which may be paid or issued by the Debtor in satisfaction of the Claim (collectively, the “*Transferred Rights*”).
